

Official Rules for the Quarantine Cosplay Photo Sweepstakes

No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- Eligibility:** The Sweepstakes is open only to legal residents of the United States who are at least eighteen (18) years old. Employees of Beasley Media Group, LLC d/b/a Checkpoint XP (“Sponsor”), as well as the immediate family (spouse, parents, siblings, and children) and household members of those employees, are not eligible to enter.
- Entry Period:** The entry period for the Sweepstakes begins at 12:01 a.m. Eastern Time (“ET”) on April 2, 2020 and ends at 11:59 p.m. ET on April 30, 2020 (the “Entry Period”). Sponsor’s computer is the official time-keeping device for the Sweepstakes.
- How to Enter:** To enter, visit checkpointxp.com, follow the prompts to the Sweepstakes entry form, fill out the entry form, including a photo submission of the entrant in “cosplay” (a “Photo”), and submit. There is a limit of one (1) entry per person during the Entry Period. **Each Photo must be submitted in digital form in JPEG or PNG format (minimum 270 pixels wide and sized less than 1 MB).** Entrants must fill in all required fields, including name, email, phone number and date of birth in the online entry form. Obscene, provocative, or otherwise objectionable content will not be considered, and such determination is solely at the discretion of the Sponsor. Each Photo submitted may feature only the entrant and must not contain copyrighted materials or any other materials that may be restricted, prohibited, or outlawed by any laws, or materials that may otherwise infringe on the rights of a third party. Entrant acknowledges and agrees that professional photographs (i.e., photographs taken by a photographer who was paid to take such photographs) are not eligible unless the entrant has rights to post that Photo. The Photo may not invade publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any person’s personal or proprietary rights including but not limited to copyrights or trademarks. The Sponsor shall have the right to disqualify any entrant if it determines that the Photo contains copyrighted material or material that infringes on the rights of another; indecent or otherwise offensive material such as violence or drug abuse; or if such Photo contains material that is deemed to be unsuitable for a public audience. Photo may be posted on the Sponsor’s website or and by submitting a Photo, entrant (1) certifies that he or she has all rights necessary to use the Photo, and (2) grants Sponsor permission to use the Photo for Sweepstakes and other promotional purposes. The Sponsor’s determination with respect to all such matters shall be made in its sole discretion and shall be final. Photos that do not comply with these rules will not be eligible for the Sweepstakes. By entering the Sweepstakes, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor’s decisions regarding the Sweepstakes, which are final and binding. Winning a prize is contingent upon fulfilling all requirements in these Official Rules.

4. **Drawing:** Sponsor will select one (1) potential winner on May 7, 2020 at approximately 11:00 a.m. ET via a judging panel based on the following judging criteria: **the originality and creativity of the cosplay and the quality of the costume**. Sponsor will attempt to contact the winner via e-mail.
5. **Potential Winner Requirements:** Except where prohibited, a potential winner may be required to complete and return a declaration of eligibility and liability/publicity release within ten (10) days of notification. If a potential winner fails to sign and return these documents within the required time period, Sponsor may select an alternate potential winner in random drawing of the remaining entries. No more than three (3) alternates will be contacted.
6. **Prize:** One (1) winner will receive one (1) one hundred-dollar (\$100) Joann Fabrics and Craft Store gift card. The approximate retail value of the prize is \$100. The gift card will be subject to the terms and conditions as set forth by the issuer of the gift card. Gift cards are not refundable or transferable and may not be substituted or exchanged for cash or credit at any time, nor will gift cards be replaced if lost or stolen. A winner is responsible for paying any applicable income taxes and any and all other costs and expenses not listed above. Any prize details not specified above will be determined by Sponsor in its sole discretion. A prize may not be transferred prior to award and must be accepted as awarded. You may not request cash or a substitute prize; however, Sponsor reserves the right to substitute a prize with another prize of equal or greater value if the prize is not available for any reason, as determined by Sponsor in its sole discretion.
7. **General Conditions:** In the event that the operation, security, or administration of the Sweepstakes is impaired in any way, Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes; or (b) award the prizes at random from among the eligible entries received up to the time of the impairment. Sponsor reserves the right, in its sole discretion, to disqualify and seek damages from any individual who tampers with the operation of the Sweepstakes, violates these Official Rules, or acts in a disruptive or unsportsmanlike manner. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication. The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited.
8. **Release and Limitations of Liability:** By entering, you agree to release the Sponsor, its parents, subsidiaries, affiliates, and each of their respective officers, directors, employees, and agents (collectively, the "Released Parties") from any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Sweepstakes; (b) technical errors that may affect the Sweepstakes; (c) printing

errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Sweepstakes; or (f) injury or damage to persons or property. You further agree that in any cause of action, in no event shall the Released Parties be liable for attorneys' fees or other legal costs. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

9. **Privacy and Publicity:** Any information you submit as part of the Sweepstakes will be used in accordance with Sponsor's Privacy Policy. Except where prohibited, participation in the Sweepstakes constitutes your consent to Sponsor's use of your name, likeness, voice, opinions, biographical information, and state of residence for promotional purposes in any media without further payment or consideration.
10. **Disputes:** You agree that any disputes, claims, or causes of action arising out of, or connected with, the Sweepstakes shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Naples, Florida. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of Florida, without giving effect to any choice of law or conflict of law rules (whether of Florida or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Florida.
