

Official Rules for the 24 Days of Holiday Giveaways

No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- Eligibility:** The Sweepstakes is open only to legal residents of the United States who are at least eighteen (18) years old. Employees of Beasley Media Group, LLC d/b/a Checkpoint XP (“Sponsor”), as well as the immediate family (spouse, parents, siblings, and children) and household members of those employees, are not eligible to enter.
- Entry Period:** The entry period for the Sweepstakes begins at 9:00 a.m. Eastern Time (“ET”) on December 2, 2020 and ends at 11:59 p.m. ET on December 2, 2020 (the “Entry Period”). Sponsor’s computer is the official time-keeping device for the Sweepstakes.

There is a limit of **seven (7)** entries per person, per day, during the Entry Period. Entrants will receive up to one (1) entry for following the link to do each of the following:

 - Retweet the Giveaway TweetEntrants must fill in any required fields, including name, email, phone number and date of birth in the online entry form. By entering the Sweepstakes, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor’s decisions regarding the Sweepstakes, which are final and binding. Winning a prize is contingent upon fulfilling all requirements in these Official Rules.
- Drawing:** Sponsor will select five (5) potential winners on each day from December 2nd – December 24th 2020 at approximately 10:05 a.m. ET and one (1) winner on December 26th 2020 at approximately 10:05 a.m. ET for the prize offered on December 24th 2020 via a Sponsor-conducted random drawing from all eligible entries received during the Entry Period. Sponsor will attempt to contact the winners via provided e-mail.
- Potential Winner Requirements:** Except where prohibited, a potential winner may be required to complete and return a W-9, declaration of eligibility and liability/publicity release within ten (10) days of notification. If a potential winner fails to sign and return these documents within the required time

period, Sponsor may select an alternate potential winner in random drawing of the remaining entries. No more than three (3) alternates will be contacted.

 - II. One (1) Steam code for the video game GRIP: Combat Racing
7. **Prize Condition:** The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. The gift card will be subject to the terms and conditions as set forth by the issuer of the gift card. Gift cards are not refundable or transferable and may not be substituted or exchanged for cash or credit at any time, nor will gift cards be replaced if lost or stolen.
8. **General Conditions:** In the event that the operation, security, or administration of the Sweepstakes is impaired in any way, Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes; or (b) award the prizes at random from among the eligible entries received up to the time of the impairment. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication. You further agree that in any cause of action, in no event shall the Released Parties be liable for attorneys' fees or other legal costs. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.
